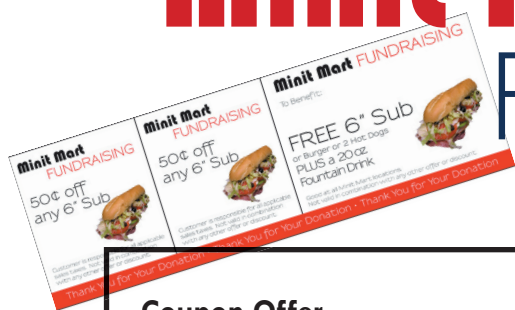

Coupon Offer

The coupon is a three-part coupon. Your customer would receive their choice of a 6" Sub. Burger, or 2 Hot Dogs plus a 20 oz. Fountain Drink for "FREE". Also included are two coupons good for 50 ¢ off their next purchase of a 6" Sub.

The Coupons can be redeemed at any Minit Mart location and have no expiration date.

The Coupons will be sent to you in books of 10. Example: If you order 200 coupons, you will receive 20 books.

Coupon Cost

You will sell the coupons for \$4.00 each and will submit \$2.75 each to Minit Mart, thereby making a \$1.25 profit for each coupon sold.

Payment Terms

Minit Mart will give you 60 days to sell the coupons before you must send payment for the sold coupons and return any books that were not sold.

There is a \$2.00 charge for any books not sold (regardless of the quantity of coupons remaining in the books). Please be advised that we do not accept single (returned) coupons.

Minimum Order

A minimum order of 200 coupons (20 books) is required .

AGREEMENT

THIS AGREEMENT, MADE THIS _____ DAY OF _____, 200__ BETWEEN MINIT MART OF 1540 MARTIN STREET, STATE COLLEGE, PA AND _____ (ORGANIZATION) HERINAFTER REFERRED TO AS "ORGANIZATION".

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. MINIT MART WILL PERMIT THE ORGANIZATION TO SELL COUPONS FOR SANDWICHES FOR PARTICIPATING MINIT MART STORES AS PART OF A FUNDRAISING PROJECT FOR THE ORGANIZATION.
2. UPON RECEIPT OF THE COUPONS ORDERED, THE ORGANIZATION AGREES TO REIMBURSE MINIT MART \$2.75 PER COUPONS SOLD PLUS AN ADDITIONAL \$2.00 PER BOOK FEE FOR EACH UNSOLD BOOK RETURNED REGARDLESS OF THE NUMBER OF COUPONS IN THE BOOK. THIS PAYMENT MUST ACCOMPANY THE PAYMENT FOR SOLD COUPONS IN THE FORM OF A CHECK OR MONEY ORDER AND SENT DIRECTLY TO MINIT MART, 1540 MARTIN STREET, STATE COLLEGE, PA 16803, ATTN: FUNDRAISING COORDINATOR.
3. THE UNDERSIGNED, INDIVIDUALLY AND ON BEHALF OF THE ORGANIZATION, AGREES TO BE HELD RESPONSIBLE FOR THE NUMBER OF COUPONS ORDERED ABOVE AND RECEIVED FROM MINIT MART FOR SANDWICHES AND HEREBY AGREES FURTHER TO BE INDIVIDUALLY LIABLE FOR THE PAYMENT ON ALL SOLD COUPONS; THE RETURN OF ANY AND ALL UNSOLD COUPONS; PLUS FEES AND PAYMENT FOR LOST OR STOLEN COUPONS WITHIN 60 DAYS OF THE AGREEMENT DATE STATED ABOVE.
4. IF COUPONS ARE LOST OR STOLEN, THE ORGANIZATION WILL REIMBURSE MINIT MART FOR \$2.75 PER COUPON WHETHER OR NOT THE LOSS IS DUE TO ANY NEGLIGENCE ON THE PART OF THE ORGANIZATION.
5. THE ORGANIZATION AGREES TO INDEMNIFY AND HOLD HARMLESS MINIT MART IN CONNECTION WITH ANY LIABILITY INCURRED AS A RESULT OF THE SALE OR DISTRIBUTION OF THE COUPONS FOR SANDWICHES AS REFERRED TO HEREIN.
